# **CORRIGENDUM**

Please find hereafter the missing paragraph of Article 3 of the "Implementing Provisions concerning the grant of building loans", published in the "I.A. Spécial interinstitutions" of 21.3.1986, page 32 :

## Article 3

1. Property for which loans may be granted must be situated in a Member State of the Community.

However, loans may be granted :

(a) to an official who is not a national of a Member State for the construction, purchase or conversion of property in his country of origin;
