#### A. FELLOWSHIPS 1994/1995 in the United States

### 1. At the Center for International Business Education and Research. University of Washington. Seattle

The University of Washington in Seattle is the largest and most respected public institution in the Northwest quadrant of the US, and is noted for its international programs. The EC Fellow will be hosted Jointly by the Jackson School of Studies School of International and the Administration, through its Center for International Business Education and Research. Ideally, the EC Fellow would participate fully in the academic life of these two schools. The Fellow could teach one or more special seminars or courses during the academic year, could give talks in other classes and in the Seattle community, and could maintain close contact with faculty and students. Each seminar or course would involve one or two class meetings per week for ten weeks. Some financial support for teaching seminars is made available by the University.

The ideal profile for an EC Fellow would be a person who has a strong background and experience in the relationships of the European Community with the rest of the world. The University is especially interested in somebody with a background in economic and financial affairs, industrial and competition policy, or international trade. Ideally, the person would have some academic experience or a strong interest In teaching. The academic year runs from end of September 1994 through mid June 1995.

### 2. At the Center for International Affairs. Harvard University. Cambridge. Mass.

The Community institutions will send a senior permanent official to the Center for International Affairs, at Harvard University, as a Fellow for the academic year September 1, 1994 to June 30, 1995; C.F.I.A. has expressed a strong preference for a woman official in a management position and applications are invited from suitable qualified candidates.

#### Fellowship at the C.F.I.A.

The principal objectives of the Center for International Affairs are to encourage interdisciplinary research on major problems in the field of international affairs and to promote and pursue an interest in international affairs at Harvard University, largely through informal educational activities among faculty members, fellows, research associates, students and various other groups.

Each year the Center gathers a group of about twenty people involved in international affairs, mainly senior officials from various countries around the world, who spend a full academic year as Fellows of the Center doing intensive study. Fellows hold appointments as Officers of the University and thus have access to virtually all the resources of University. They are colleagues of the Faculty, not students. The Program is structured to maximize Fellows' opportunity to pursue their own interests in their own way. Some concentrate on research and writing, others focus on new developments in their fields, attending seminars and lectures at Harvard, MIT and other universities in the Boston area. Still others will organize a seminar or workshop on a specific subject of interest. Most do some of all of these. Each Fellow is encouraged to write at least one analytical paper on a selfselected topic.

With varied geographical and professional backgrounds, with different ways of looking at the world and diverse analytical and decision-making experience, Fellows have much to offer and receive from their colleagues. The University environment permits a quality of uninhibited discussion seldom achieved in official contacts.

The Center takes broad interest in European Community policies. Areas of particular interest include the role of the European Community in the world (e.g. international relations of a strategic, political or commercial character), the evolution of Community institutions, as well as Community policies in the field of new technologies, for example.

Besides participating in seminars on a wide variety of topics in international affairs organised by the Center, the EC Fellow should closely cooperate with the Center for European Studies and The Center for Middle Eastern Studies. In addition, other departments of Harvard University might request help in organising courses, seminars or study groups on some aspects of the European Community. The Commission's Washington Delegation could likewise request the Fellow to speak on certain occasions.

### 3. At the Center for European Community Studies. George Mason University. Fairfax. Virginia.

George Mason University is a dynamic institution that provides a diverse and interactive curriculum to educate students for life in a rapidly changing, highly technical world. More than 20,000 students study in close to 100 degree programs at the undergraduate, master's, doctoral, and professional levels. Its innovative programs and visionary outlook have attracted a faculty of world-renowned scholars and teachers.

Opportunities for EC Fellows exist in the following units of George Mason University:

- Center for European Community Studies, Director, Dr. D. Dinan and
- Center for the Study of International Technologies, Decision Sciences & MIS, Director, Dr. E. Anderson.

In either center, the EC Fellow would work closely with the center Director to develop curricula, courses and programs, organize and participate in conferences, seminars and workshops. The EC Fellow would contribute to the research agenda of the centers.

An office and full administrative support is offered by the University. For persons with substantial experience, there may be some support toward flight expenses to and from the US. The academic year runs from September 1, 1994 to May 31, 1995.

### 4. At the Fletcher School of Law and Diplomacy. Tufts University - Medford. Massachussetts

The Fletcher School of Law and Diplomacy was established by Tufts University with the assistance of Harvard University in 1933 as the country's first graduate professional school of relations. It is international a competitive. selective school which tries in its curriculum and professorate to combine practice and theory.

The Fletcher School is very committed to teaching as well as being a graduate research institution. The EC Fellow will be asked to teach her/his own course or seminar institutions and workings of the European Communitites and their current policies, as experienced "from the inside". Instruction and advising students will therefore take up a considerable amount of time during the fellowship. Due to the administrative relationship between Fletcher Harvard, and the closeness of a third prestigious school in the area, MIT, the Fellow is likely to attract students from perhaps other institutions, and those and possibilities of intellectual interchange within the wider Boston academic, business and political community.

The academic year runs from September 1994 to June, 1995.,

### 5. At the Lyndon B. Johnson School of Public Affairs. International Policy Studies. University of Texas. Austin

In its 6th year, the EC Fellowship at the LBJ School will be invited to contribute to the multidisciplinary research of the school through active participation In Policy Research Projects, to give a Masters level course or seminar European Affairs within the University of Texas to Masters and Doctoral students from the whole system, utilise the resources of the EC Depository and Presidential Library, take a special interest in regional issues and take the opportunity to work in the region. other academic institutes Specific strengths currently include issues around the recently passed North American Free Trade Agreement (NAFTA), The Mexico Free Trade Agreement, Environmental Management of Resources, Latin America, infrastructure and transportation policy.

The School is characterised by a close link to the University of Texas system, the Texas State legislature, the Johnson Presidency, and an international basis and outlook In. its staff, other visiting fellows, and students that belles its location. The EC Fellow will be asked to develop contacts in EC institutions for faculty and associated research staff, and support the schools EC stagiaire scheme with preselection of candidates. The EC Fellow can be expected to have to give talks to local political, public interest and business bodies on current issues of EC regulations and policy affecting the working and trading relationships between the US, specifically Texas, and the EC. There is a Independent, current, information flow from the level main and extensive corpora of catalogued background documents for the Fellow to build on. The academic year starts early in September through to the following May/June period.

#### 6. At the Law School. University of Michigan

The Law School of the University of Michigan is interested in hosting an EC official at some point during the 1994-1995 academic year or later. A minimum period of three or four weeks is desirable; a longer visit also can be useful.

The ordinary purpose of a visit is to offer a course or seminar on some topic within the expert knowledge and experience of the visitor. Any topic relating to the European Commission would be especially welcome. Also welcome would be topics of international trade or international law. The most helpful topics will depend on the topics offered by other short-term visitors from other countries.

Students who already hold bachelor degrees would primarily constitute the participants of the course.

#### 7. At the School of Law. Emory University. Atlanta. Georgia

Emory University is a private university in a residential area six miles east of downtown Atlanta and in close proximity of the Carter Presidential Center, which houses President Carter's Library and archives. Former President Carter is now a University Distinguished Profesor at Emory and a visiting Lecturer in the School of Law. The professional program of the School of Law enrolls close to 700 students and has a full-time faculty of 35. The School has a strong program in international and comparative (particularly European) law. Its Library is a depository of EC materials.

Emory Law School is very much interested in broadening Its international and comparative law offerings. It is for this reasons that it would like to host an EC Fellow. The EC Fellow would teach a regular basic European Community law course (three hours per week), including the administration and grading of the regular American law school type final examination at the end of the semester. The course enrolls, on average, some 30-40 students. In addition, the Fellow should be prepared to give an occasional lecture to a more general university or professional audience.

Some funding by Emory regarding air travel, housing and living expenses can be arranged.

Preferred dates of appointment: mid-August to mid-December 1994.

### 8. At the University Center for International Studies University of Pittsburgh

For the second time, the University of Pittsburgh, through its Director of the West European Studies Program, Prof. Alberta SBRAGIA, an EC-Fellow is invited.

The Fellow would not teach regular courses but instead would be used as a resource person for undergraduate and graduate students, faculty, and the local business/professional community. The Fellow would be integrated into the many activities of the West European Studies Program. He or she might, for example, be invited to give general talks on the Community in undergraduate courses, more specialized ones to graduate students in the social sciences, business, and law, and to work at a still more specialized level with doctoral students planning to carry out research in Brussels In his/her area of expertise. If willing, he/she would be invited to address business groups in the city as well as the academic community comprised of small colleges and private universities in the surrounding region.

The person of most interest to the University would be someone with knowledge of the area of environmental policy or of the single market. A person who can explain the link between the two would be of particular interest.

Within the environmental policy area, someone knowledgeable about the linkage between trade and the environment or the use of fiscal/economic instruments would be welcome. The University has a strong research interest in the area of technical standards and policy implementation and compliance.

Within the single market area, someone with an understanding of how regulatory reform within the Community has affected the Community's external economic relations would be an asset.

The ideal candidate would be interested in any of the following:

- 1) carrying out research on American environmental policy.
- carrying out historical research on how the American internal market was created and how it differs from the European
- 3) the impact of deregulation in the United States on American external economic relations
- 4) comparing how environmental regulations have changed business-government relations in the United States and Europe.

The University will provide office space, telephone, some secretarial support, and assistance in finding appropriate' housing and schooling for the Fellow and his/her f-amily.

### 9. At the Woodrow Wllson School of Public and International Affairs. Princeton University. Princeton. New Jersey

Princeton University's Woodrow Wilson School of Public and International Affairs, founded in 1930, offers programs designed for professionals working in public affairs. The philosophy of all programs at the foundation is a commitment to public service. It seeks to meet the needs of both the government and the private sector for individuals who are broadly trained to create, interpret, and implement public policy. As a way of enriching both the intellectual life and vitality of the School and contributing to the public service, the school offers the opportunity to spend an academic year at

Princeton to a select group of men and women already established in careers related to public service. Over the years, this program has drawn participants from more than 40 countries around the world. It is designed to provide an educational opportunity for men and women preparing to assume positions of broader responsibility or seeking to understand better the implications of their present duties. It is intended to acquaint the participants with current issues in, and modern techniques for, analysis of development economics, international politics, international economic issues, and domestic policy matters

Each participant in the program has the opportunity to study with the School's faculty, make full use of the University's resources, and follow an individually tailored course of study. The program is small, usually about 25 individuals, which encourages an atmosphere of collegiality and ensures maximum interaction with the faculty. In addition, bi-weekly luncheon seminars provide participants with opportunities for frank and intensive discussions with faculty from the School, other departments of Princeton University and professionals from the community. Formal courses are supplemented by conferences, lectures, debates, and discussions with scholars from Princeton and other universities, with administrators from the federal, state, and local governments, and with experts from various fields. Fellows are eligible to earn certificates in two areas Science, Technology and Public Policy, and Demography

The 1994/95 term will begin on September 1, 1994 and conclude by May 20, 1995.

#### SEATTLE-HARVARD-GEORGE MASON-TUFTS-AUSTIN. TEXAS-MICHI GAN-EMORY.ATLANTA-PITTSBURGH-PRINCETON

#### Selection criteria

As far as the EC-institutions are concerned, the main selection criteria will be the overall calibre of the candidate, taking account of his/her intellectual vigour, analytical capacity, his/her degree of personal Initiative, originality in writing and discussion and general knowledge of European Community Policies. For Harvard, the subject of personal study chosen, which should interest both the EC and the C.F.I.A., will be subject to the approval of the Selection Committee

#### Qualifications required

- Minimum of five'years' experience as a permanent official of one of the Community institutions;
- Good command of the English language, both written and oral;
- High degree of personal initiative and organizational talent;
- Good knowledge of Community policies and US-EC relations in general as well as trade questions in particular;
- Ability to contribute to teaching and discussion on the European Community;
- Excellent communication skills and "public relations-oriented":
- Excellent knowledge of a particular policy of the European Community, which will be the subject of special study in the C.F.I.A., to be defined in the application (please include a one-page description);
- Ability to do research.

#### **Conditions**

The special terms will be extra-statutory and their duration will be strictly limited to the academic year or semester plus a week beforehand for installation.

Candidates will be reimbursed the reasonable cost of suitable furnished accommodation, within the ceiling permitted for mission hotel expenses (currently 125 ECU/day) and will be paid a daily allowance of 75 ECU (A1-A3) or 60 ECU (other grades), applying by analogy the reduction in respect of missions of long duration; no derogation from this reduction will be accorded.

Apart from the initial return flight, the unaccompanied Fellow will be reimbursed the cost of 2 return flights to Brussels (or Luxembourg) during the Fellowship in case of an academic year. No such return flights will be accorded to candidates accompanied by their families, In the case of a semester see conditions stated under Brookings., In the case of a quarter, one initial return flight only.

All flights will be on the basis of the most economic rates available, and the weight of personal luggage and necessary documents will be limited to 250 kg on the initial Journey and on return.

Mission expenses are to be covered by the candidate's Directorate general or Service.

N.B. For universities offering a whole academic year, the Coordinating Committee for Exchanges will endeavour to negotiate shorter periods of studies if so required.

### B. GUEST SCHOLARSHIP AT THE BROOKINGS INSTITUTION. WASHINGTON D.C.

The EC Institutions again plan to send a Guest Scholar to the Brookings institution for a period which normally extends from January to the following June but which can be varied, since Brookings is not bound by the academic year.

Applications are invited from qualified candidates, preferably at A5 level or above.

The Brookings Institution has developed over fifty years as a center for non-partisan research on issues of importance to U.S. society in general and to governmental policy-making in particular, and it enjoys outstanding prestige in U.S. policy-making circles. The guest scholarship may be seen as an opportunity to contribute to research and to the formulation of policies which could have a real impact on relations between the U.S. and the European Community.

#### Brookings offers three resources to the quest scholar:

- access to leading specialists in the particular field of research;
- easy access to government officials;
- good library services.

The guest scholar usually works in close contact with a Senior Fellow, who will also help to establish connections with suitable people outside Brookings. The contribution of the guest scholar to the work of the Institution is expected in terms of discussion and communication of research results with Fellows in the same or related field.

#### **Research Topics**

Candidates may suggest their own topics for research, which must be those likely to be in the forefront of public policy interest both in Europe and in the United States during the period of the scholarship. Contacts with the Brookings Institution suggest that such topics migh include:

- Competitivenes labour market + industrial policy
- Social Policy medical care costs, welfare/poverty, aging population, social security.
- Macro Economics eco-forecasting, inflation/deflation.
- International Economics.

#### **Conditions**

The special terms will be extra-statutory, and their duration will be strictly limited to the length of the scholarship (6 months), plus a week beforehand for installation.

The candidate will be reimbursed the reasonable cost of suitable furnished accommodation, within the ceiling permitted for mission hotel expenses (currently 125 ECU/day) and will be paid a daily allowance of 75 ECU (A1-A3) or 60 ECU (other grades), applying by analogy the reduction in respect of missions of long duration; no derogation from this reduction will be accorded.

Apart from the initial return flight, the unaccompanied Brookings Scholar will be reimbursed the cost of 1 return flight to Brussels (or Luxembourg) during the scholarship. No such return flight will be accorded to candidates accompanied by their family.

All flights will be on the basis of the most economic rates available and the weight of personal luggage and necessary documents will be limited to 250 kg on the initial Journey and on return.

Mission expenses are to be covered by the candidate's Directorate general or Service.

#### C. UNITED STATES-EUROPEAN COMMUNITY FULBRIGHT PROGRAM

funded through the U.S. Information Agency and administered by the Brussels Fulbright Commission, the U.S.-E.C. Fulbright Program will provide the following grants for the academic year 1994-1995:

For all of these grants, the Fulbright Commission will provide a monthly stipend of \$ 2,200 as a salary supplement, roundtrip travel for the official at the most economic rates, visa sponsorship, and health and accident insurance.

#### 1. Fulbright grants for research

One full year or two one-semester awards for an EC official to conduct independent research in the United States, at an accredited university or an independent research center, such as the Brookings Institution, the American Enterprise Institute, the Center for Strategic and International Studies, the Library of Congress or the Wilson Center. The candidate is responsible for arranging his/her own affiliation with an appropriate research center in the U.S.

#### 2. Ful bring scholar-1n-residence program

The following American universities wish to host a senior, permanent EC official for the academic year 1994-95 or one semester of the academic year 1994-95 as a Scholar-in-Residence:

#### a. The University of Illinois at Urbana-Champaign

The University of Illinois seeks an EC official with a broad understanding of EC affairs and with special depth of experience in such areas as economic and monetary integration in Europe, the regulation of business and markets, economic competition, and trade and agricultural policies.

The visitor will be sponsored by the Committee for European Studies at UIUC. The program will involve the EC official with students and faculty in lectures, seminars, consultation and research in 10 colleges, departments and centers at UIUC, in meetings with community organizations and in similar activities for briefer periods at five other major universities in the Midwest. The official will be encouraged and assisted in attending relevant professional conferences and association meetings.

The College of Commerce and Business Administration is establishing a new Center for International Business Education and Research, which will have an emphasis on teaching and research programs involving member states of the EC. The increased emphasis on the EC makes it especially valuable and timely to have an EC official in residence during the 1994-95 academic year.

Conditions In addition to the initial award available from the Fulbright Commission (see above), the University will provide a salary supplement of \$3,000, a travel allowance of \$3,000, secretarial assistance, office space, computer access, library services, etc.

Preferred Dates of Appointment • August 20 - December 20, 1994

#### b. The University of Wisconsin - Madison

The University of Wisconsin-Madison is one of the country's largest and most prestigious institutions, generally ranking among the top ten of all U.S. universities. The University has consistently housed distinguished scholars working on European Studies, especially in departments such as history, political science, and sociology.

In recent years, Europeanists in a wide variety of departments have felt the need to collaborate more in a focused inter-disciplinary program. European Studies is now engaged in a number of activities such as reviewing its curriculum, fund raising, and sponsoring regular lecture series Hosting an EC official would help to enhance these efforts

The scholar would be invited to participate as a guest lecturer in existing courses which deal specifically with the EC and in other courses which have EC components, in roundtable discussions, and in helping to enrich curricula with an insider's perspective and knowledge. The scholar could also contribute to courses in his/her area of speciality in any of the following areas: law, business, foreign trade, agricultural economics/rural sociology, environmental studies, public policy, workplace health and safely, etc.

Conditions: In addition to the initial award available from the Fulbrlght Commission (see above), the University will offer a salary supplement of \$2,500 and in-kind support services (services of a research assistant, use of computer, office supplies, etc.)

Preferred Dates of Appointment: Sept, 6 ~ December 23. 1994 or January 23 - May 20, 1995.

#### c. The University of Wisconsin - Milwaukee

The University of Wisconsin - Milwaukee is a comprehensive university offering degrees at the baccalaureate, master's and doctoral levels. It has a total enrollment of 25,000. The student body is unusually diverse in that many students are older, employed, have worked or studied elsewhere and represent a broad spectrum of racial groups.

There are eleven international area studies programs on campus, over twenty study abroad programs to 14 countries, and a newly-created Center for International Studies. The Institute of World Affairs was established in 1960 and has a long tradition of providing outstanding public education programs on U.S. foreign policy and international issues.

The Scholar-In-Residence would be asked to teach an upper-level course on "Political Integration of Western Europe", if he/she so desires. The university would also like to involve the scholar in a review and analysis of European studies on the campus in general. The scholar would also be Involved in the development of and participation in community eduction programs aimed at the Milwaukee business/corporate sector and at the secondary schools, in addition to the general public. Particular fields of interest are government, history, economics or law.

Conditions: In addition to the initial award available from the Fulbright Commission (see above), the University will provide a salary supplement of \$ 5,000, office space, secretariat assistance, and travel support.

Preferred Dates of Appointment: Sept. 1, 1994 - May 31, 199S; or October 1, 1994 - June 30, 1995.

#### d. Case Western Reserve University, School of Law

Case Western Reserve University, located in Cleveland, Ohio, is one of the preeminent institutions in the region. The Law School has an enrollment of around 675. The Gund Foundation International Law Center will arrange and oversee the scholar's activities. Particular areas of expertise requested are conflicts of law and international legal harmonization.

The scholar would be asked to lecture and conduct workshops and seminars at the Weatherhead School of Management at Case Western and at the law schools of Cleveland State University, Ohio State University, Akron University, and the University of Toledo. The scholar will also give public lectures and act as a valuable resource by participating in area high school social studies courses. The scholar will also assist in curriculum development and suggestions for expansion of the library's EC collection.

Conditions: In addition to the initial grant available from the Fulbright Commission (see above), the University will provide a salary supplement of \$4,000, \$3,000 for housing, \$2,500 for living expenses, support for travel to conferences, office, and a computer.

Preferred Dates of Appointment: January 10 - June 10, 1995; or August 20 - December 30, 1994.

#### e. Georgia Institute of Technology, Atlanta

Georgia Institute of Technology is a component of the University System of Georgia. Enrollment here has grown from the first class of 129 mechanical engineering students in 1888 to more than 12,000 students from 90

countries enrolled in programs in engineering, sciences, computing, architecture, and management, policy and international affairs.

The scholar would be affiliated with the College of Management, Policy and International Affairs and his/her contributions could include the following: teach an undergraduate international affairs course on "The Politics of European Integration"; participate in a senior seminar on international strategic planning and analysis; work with a faculty committee to assess the Brussels Summer Program; work with faculty to assess the international political economy course offerings and develop new courses; work with faculty in international affairs, management, economics, and modern languages in the design and implementation of new degree programs for undergraduates and graduates. Desired areas of expertise are: political economy and industrial policy and relations, but scholars in the area of international affairs and/or management would be acceptable.

Conditions: In addition to the initial award available from the Fulbright Commission (see above), the University will provide a salary supplement of \$2,000, support for travel to conferences, office and secretarial assistance, etc.

Preferred Dates of Appointment: Sept. 18 - December 10, 1994; or January 3 - March 17, 1995.

#### f. Sacred Heart University, Fairfield, Connecticut

Sacred Heart is a private, non-sectarian, coeducational institution, located in southwestern Connecticut. It was founded in 1963 and is uniQue in character as a lay-staffed Catholic institution. In the fall 1993 semester, the University enrolled Just over 5,000 students.

During the last five years. Sacred Heart has made significant strides in internationalizing the university. In 1992, a new undergraduate international business major was introduced, and a new global studies major began in September 1993.

Sacred Heart is seeking a scholar with expertise in economics, accounting and/or finance and with a broad vision of the EC. The presence of an EC scholar-inresidence will assist the university in its efforts to enhance its international curriculum and faculty development and assist in building partnerships with other institutions in the country committed to international education

The scholar will contribute to Sacred Heart's European Area Studies Institute, assist faculty to create new courses dealing with the EC and revise syllabi for existing courses. The scholar would also participate in an interdisciplinary, international studies faculty development seminar.

The scholar would also be included in the programs of surrounding institutions and will have access to local research facilities, including the library at Yale University as well as the many resources of nearby New York City.

Conditions in addition to the initial award available from the Fulbright Commission, the University will provide a salary supplement of \$8,000 (\$1,500 per month), possible subsidized housing (in which case the salary supplement would be reduced, but total support would exceed the \$1,500 monthly supplement), travel to conferences, office, secretarial services, etc.

Preferred Dates of Appointment: Aug. 20 - Dec. 20, 1994.
